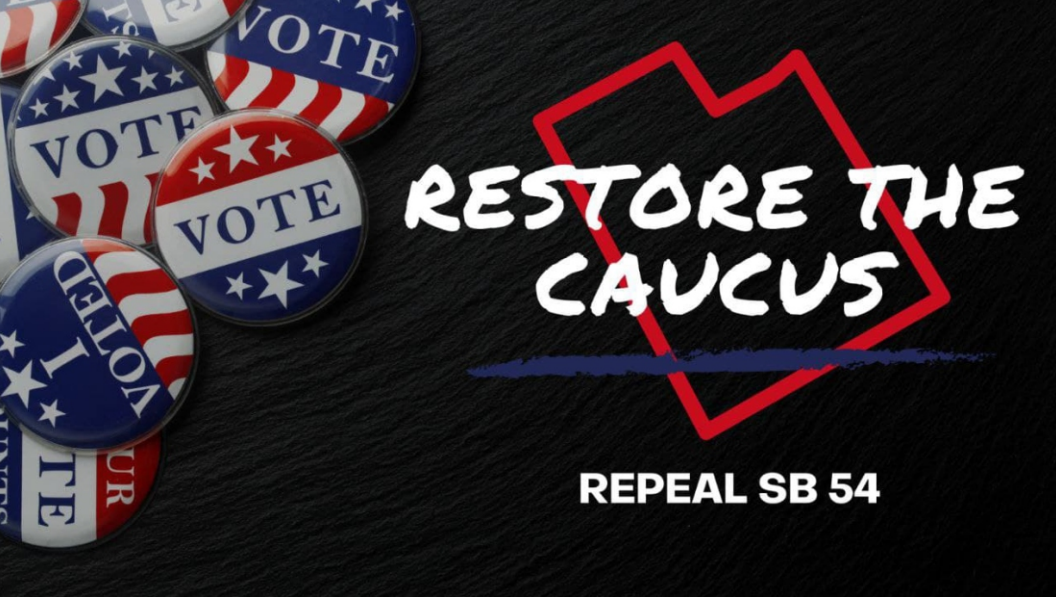

BRING BACK THE CAUCUS AND OUR VOICE

WHY WE NEED TO REPEAL SB 54

1) SB 54 (which created the dual-path) was a clear **attack** on the **rights of Freedom of Speech and Assembly**. Government dictating to a private organization how it should choose its candidates is not appropriate.

2) The **caucus system makes money less of a factor**. (Yes there are examples where a candidate deluged delegates with meals etc.) but by and large, it **evens the playing field**. It puts the **focus on ideas not on who has the most money** for ads.

3) **The caucus system is representative of our republic**. Neighbors elect those who will represent them. It requires them to ask their neighbors about their beliefs.

4) The caucus system allows individuals to organize. Because you find out what your neighbors and friends believe in, it is **easier to organize on matters**.

5) The **caucus/convention system gives grassroots more of a say in their party**. Robust conventions allow grassroots members to have more of a say in their party. If we lose conventions, we lose the voice of grassroots delegates.

With Rank Choice Voting, you rank your choices on the ballot.

	Preference Ranking			
	1st Choice	2nd Choice	3rd Choice	4th Choice
Candidate A	●	○	○	○

Candidate D	○	●	○	○

To win a seat, a candidate must receive over 51% of total vote. For example, a total of 100 voters will require 51 votes to win.

	Fred	Alice	Sarah	George
1st count:	39	35	20	6

First the 1st choice votes are counted. Look--no one has 51 votes or more.

The loser, George, is eliminated. But the 6 people whose 1st choice was George now have their 2nd choice votes counted and transferred to those candidates.

2nd count:	39	35	20	6

	43	36	21	

There is still no winner with majority of 51 or more votes! So Sarah is eliminated and her votes are transferred according to next choice.

WANT TO KNOW MORE ABOUT RCV?

RANKED CHOICE VOTING

There are **funds to promote RCV from the government**. It appears they feel it's okay to give money to the opposition and not those trying to stop or remove RCV. How can the opposition get government money?

Grace Ramsey (**Who is paying Grace?**) will be coming back to Utah once the candidates for RCV have filed **to start really pushing and helping candidates**.

RCV **encourages candidates to run and support another candidate**. Team up with someone and support them as 2nd or 3rd choice.

Follow up to the above: **Work with your competition to team up**. Get voters to choose you second.

Mayor of Vineyard is really pushing for this. Utah RCV will also be hitting up and trying to **train all the county clerks**.

Now is the time to get keep touching base with candidates who have already filed to run and explain the negatives about RCV. The candidates and public are ill-informed.

Go to city council meetings that are trying to discuss RCV and make your voice heard. Keep in contact with your county clerk about **NO RCV!**

RIGHTS RETAINED BY THE PEOPLE

UTAH CONSTITUTION, ARTICLE I, SECTION 25

A STUDENT'S **PARENT IS THE PRIMARY PERSON RESPONSIBLE** FOR THE EDUCATION OF THE STUDENT, AND **THE STATE IS IN A SECONDARY AND SUPPORTIVE ROLE TO THE PARENT**. AS SUCH, A STUDENT'S PARENT HAS THE **RIGHT TO REASONABLE ACADEMIC ACCOMMODATIONS** FROM THE STUDENT'S LOCAL EDUCATION AGENCY (LEA)
UTAH CODE 53G-6-8

NOTHING IN THIS TITLE **SHALL PROHIBIT AN INDIVIDUAL** FROM **CHOOSING THE DIET, THERAPY, OR MODE OF TREATMENT** TO BE ADMINISTERED TO AN INDIVIDUAL OR AN INDIVIDUALS'S FAMILY
UTAH CODE 26-1-33

UNDER BOTH THE UNITED STATES CONSTITUTION AND THE CONSTITUTION OF THIS STATE, A **PARENT POSSESSES A FUNDAMENTAL LIBERTY INTEREST IN THE CARE, CUSTODY, AND MANAGEMENT OF THE PARENT'S CHILDREN**. A FUNDAMENTALLY FAIR PROCESS MUST BE PROVIDED TO PARENTS IF THE **STATE MOVES TO CHALLENGE OR INTERFERE WITH PARENTAL RIGHTS**. A GOVERNMENTAL ENTITY **MUST SUPPORT ANY ACTIONS OR ALLEGATIONS** MADE IN OPPOSITION TO THE RIGHTS AND DESIRES OF A PARENT REGARDING THE PARENT'S CHILDREN BY SUFFICIENT EVIDENCE TO SATISFY A PARENT'S CONSTITUTIONAL ENTITLEMENT TO HEIGHTENED PROTECTION AGAINST GOVERNMENT INTERFERENCE WITH THE PARENT'S FUNDAMENTAL RIGHTS AND LIBERTY INTERESTS AND, CONCOMITANTLY, THE **RIGHT OF THE CHILD TO BE REARED BY THE CHILD'S NATURAL PARENT**.

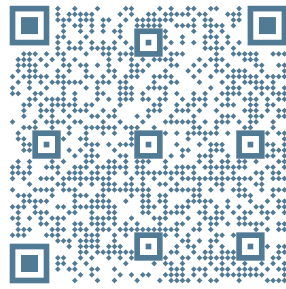

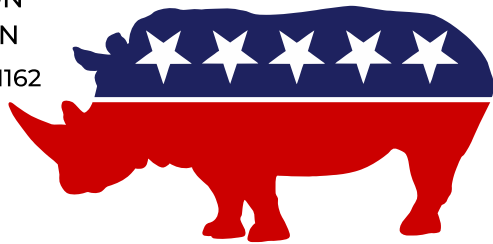
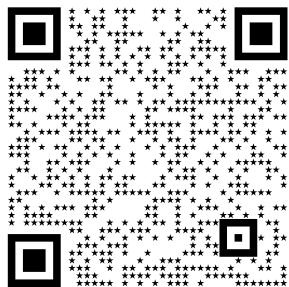

DO YOU KNOW WHAT'S IN IT?

Individual who is subject to the **order of restriction** may be required to **submit to involuntary:**

Examination, quarantine, isolation, or treatment in the individual's home, a hospital, or any other suitable facility under reasonable conditions prescribed by the department

Fines for violating "orders of constraints" can range from **\$150 up to \$5,000 per violation**

The government may **exercise physical control over property or individuals**

The government may **require an individual to perform a certain action or engage in certain behavior**

The government may close theaters, schools, or other public places or **prohibit gatherings of people. "Order of constraint"** includes a stay-at-home order.

The government may **restrict movement of the general population**

FALSE: EARLY AMBULATORY THERAPY WITH A SEQUENCED, MULTIDRUG REGIMEN REDUCES BOTH RISK OF HOSPITALIZATION AND DEATH.

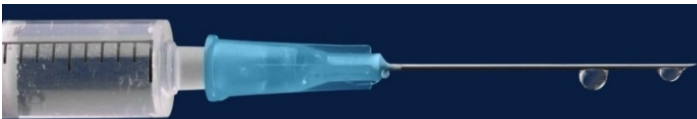

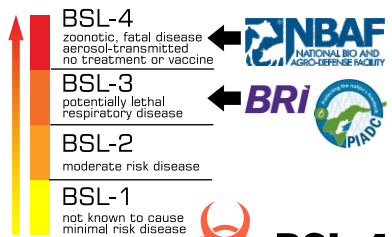
- 2012 is the last updated SSRA—A LOT HAS CHANGED
- SSRA was more concerned about spread around NBAF than long-distance spread—K-State now has 8 animal research facilities within 2 miles of NBAF and 1 Livestock Event Center across from NBAF
- SSRA in 2010 and 2012 disagreed and were controversial
- SSRA was done with 65% completion NBAF designs
- COVID-19 Pandemic devastated the world—Wuhan Institute of Virology is an Animal BSL-4

F REQUEST **REVOCATION of live FMDv permits on US mainland**

- 2008 GAO report “DHS lacks evidence to conclude that Foot-and-Mouth Disease Research can be done safely on the US Mainland”
- NBAF documents agree—highest risk from accidental or intentional release from NBAF
- 2015 a released study of Economic Impact of NBAF release found economic loss of \$16 Billion to \$140 Billion

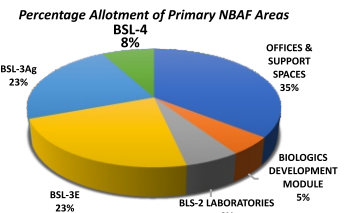
F REQUEST **RELOCATION of BSL-4 to an island location**

- EIS found risk, independent of location, based on the loss of export meat-status NOT consequences of release
- NBAF acknowledges NO OTHER BSL-4Ag in the world is located around livestock—let alone in the heart of a nation’s livestock population
- 8% percent of NBAF is BSL-4—proximity for collaboration is no longer relevant in 2021 with new technology
- Manhattan, KS was chosen because it has the lowest population of all sites—so only about 55,000 people would be sacrificed instead of millions from LETHAL release—this does not include the population outside the city



Foot and Mouth Disease, Classical Swine Fever, African Swine Fever, Rift Valley Fever, Crimean-Congo Hemorrhagic Fever, Japanese Encephalitis Virus, Nipah Virus

Rinderpest has been eradicated, but will be recreated in this lab.
