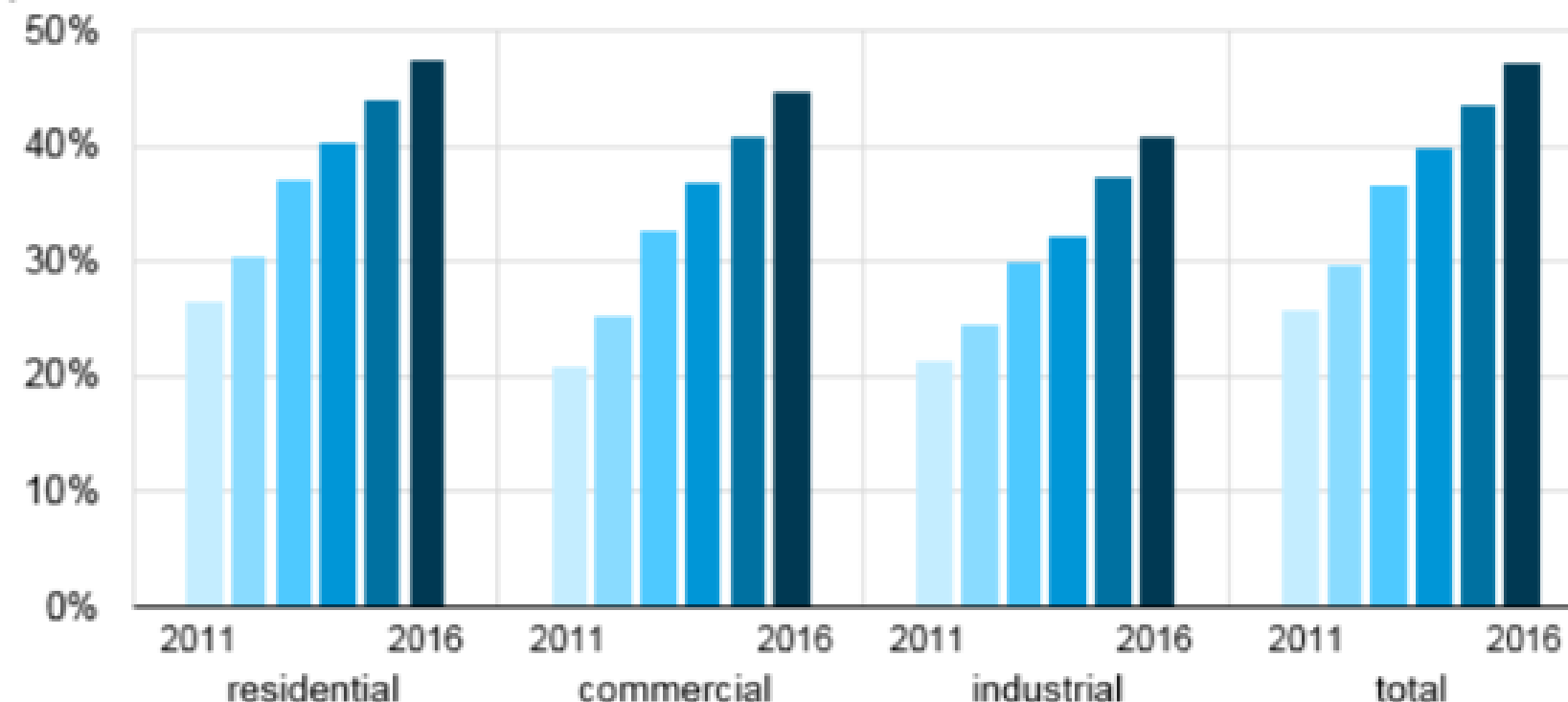
The Institute for Electric Innovation estimates that 107 million smart meters were deployed by the end of 2020, covering 75 percent of households in the United States.

SMART METER STATS FOR UTAH

(ABC4) – Rocky Mountain Power will upgrade 175,000 smart meters in Utah through the remainder of 2021 through 2022.

The new smart meters, also known as digital meters, will provide customers with timely information they need to make informed decisions about their electricity use.

Each customer will receive a letter up to a month in advance of their installation, followed by a phone call a week before an authorized contractor will be onsite, the company said in a press release.

1. Smart meters emit electromagnetic radiation (EMR) in the form of radiofrequency radiation, which is a byproduct of radiofrequency waves. No one disclaims this as one of the largest smart meter dangers.

RF radiation was classified in 2011 by the International Agency for Research on Cancer (IARC), as “possibly carcinogenic (cancer-causing) to humans.”
Furthermore, there is no data that shows RF radiation is safe.

2. Both smart meters and wireless devices emit RF radiation, however it is not uncommon for some smart meters to produce up to 60 times the US safety limit of 1,000 micro-watts per meter squared. That means the radiation from smart meters is equivalent to the output of 160 wireless devices such as cell phones

3. The WHO has determined that wireless RF radiation is a Class 2B carcinogen

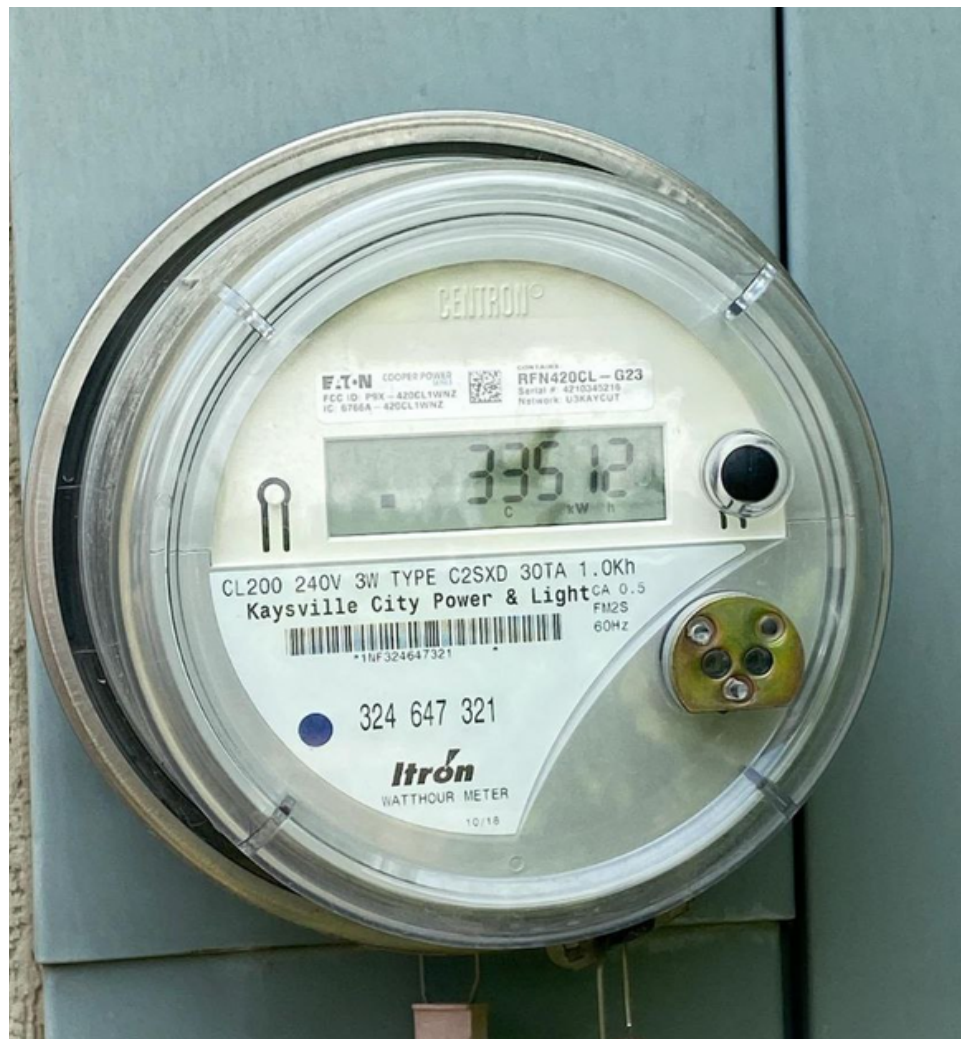

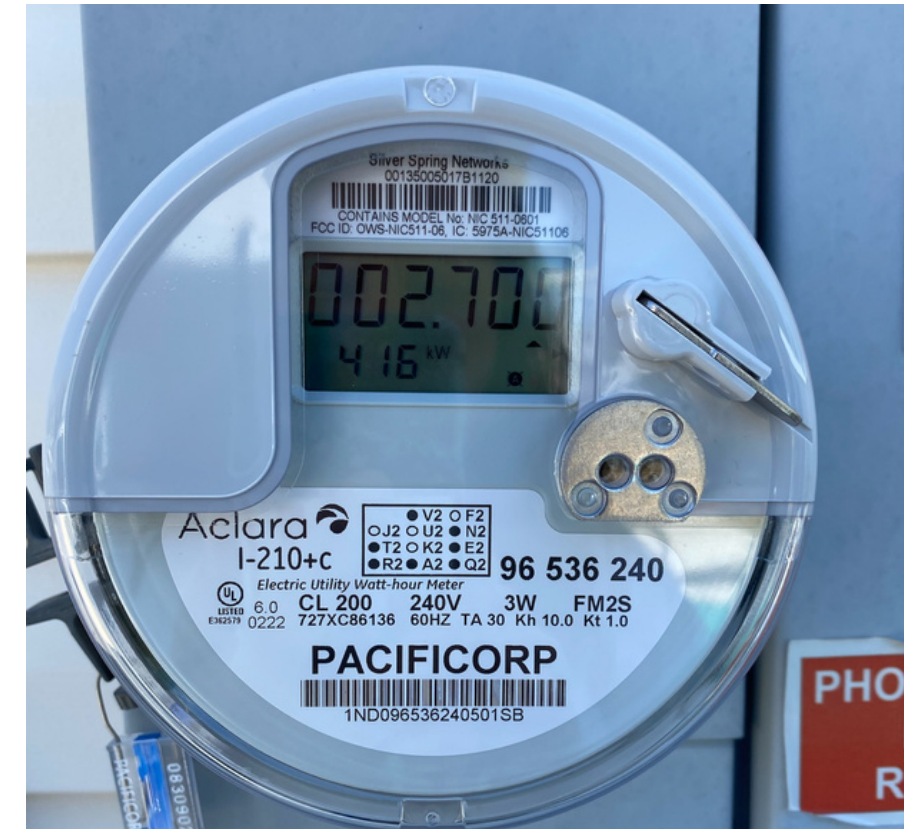

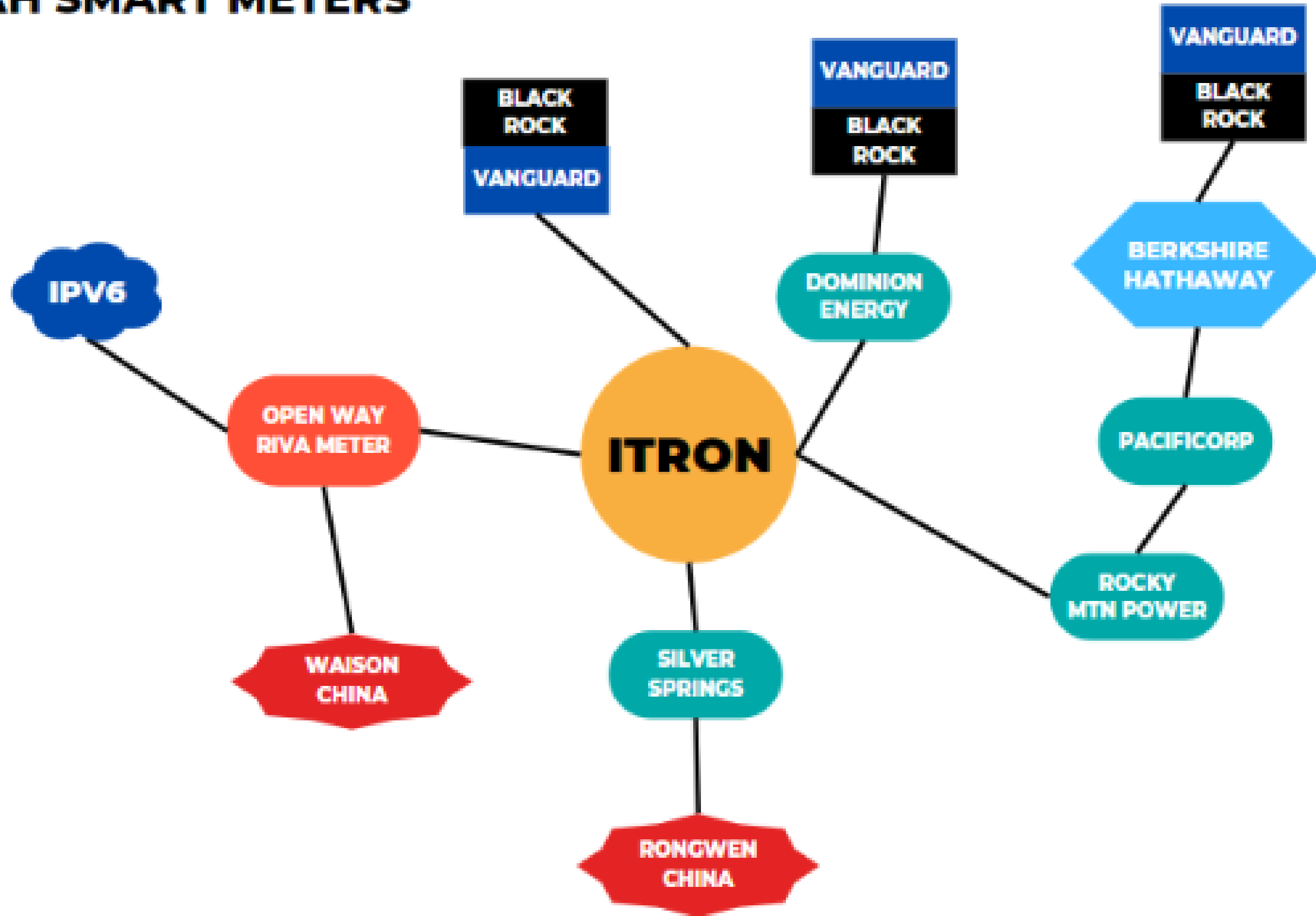

- Pulses of data (PG&E predicts they will be every 8 seconds) will collectively require storage (in a form available for online access 24/7) of absolutely huge amounts of information.
- The storage and server equipment required for this will operate 24/7 and will itself require a tremendous increase in electricity usage.
- To make the energy accounting complete, we need to not forget the contributions to overall carbon footprint by externalities such as **the manufacture, shipment and installation of all these meters, as well as the collection and disposal of still-functional analog meters.** (Will they be landfilled close to home, or shipped to Asia for disposal there?)

"Wireless smart meter systems turn out to be not a boon for the environment, but rather only a huge profit-and-control center for electronics and software manufacturers and for utilities—all of which have expended considerable lobbying money and campaign dollars to encourage federal government initiatives benefiting them."

In addition to the ongoing stream of incendiary events, so-named “smart” meter programs:

are enshrouded in fiscal negligence;

are not shown to save energy;

are linked with systemic billing inaccuracy and widespread increase of bills;

facilitate “time-of-use” billing and future artificial austerity measures;

facilitate monitoring of your activities and external control of your home;

open the door to unprecedented hacking vulnerabilities; and

emit pulsed microwave radiation typically thousands of times stronger than a cell phone, leaving many unsuspecting homeowners feeling ill.

It is difficult to imagine a more blatant failure, or a more harmful deployment of unproven technology.

If this is true, how can utilities be getting away with it?

The “smart” meter deployments in your area are actually part of a corporate-government collusion to deploy a mass in-home **data-capturing** (read *surveillance*) and control grid — the “internet of things”.

Here are three main takeaway points:

1. As new appliances are being designed to collect detailed activity and report in real-time through the “smart” meter, it’s estimated that the combined data they collect on all of us will be worth more than the entire electricity industry.
2. Industry wants to pocket trillions in this shift to an *information economy*, with **you** as the resource being packaged and sold — without your consent, of course.
3. With industry selling the wireless convenience and glorious modernization of it all, these deployments are being pushed through **under the guise of *climate action***. Go Green!

If this sounds like a stretch, **examine the evidence for yourself**.
