

# UNITED NATIONS INFILTRATION OF UTAH



Did you know Rep Weiler **passed a resolution** to protect Utah from the UN Agenda 21- **S.J.R. 11** but it was never put into law.

Did you know Over **178 nations adopted Agenda 21** as official policy during a signing ceremony at the Earth Summit. US former president **George H.W. Bush signed the document for the US**. Each nation pledged to adopt the goals of Agenda 21.

**Regionalism**- Often done through **redistricting**. Destroys traditional political boundaries (county lines) • **Abolishes private property**.

2 organizations involved in implementing regionalism are:

- Council of Governments (COG)- Wasatch Front Regional Council, Salt Lake County, Davis County, 5 Southern Utah Counties, Summit County
- Metropolitan Planning Organization (MPO)

Salt Lake City, and Summit County are members of ICLEI. The costs are paid by taxpayers.

**Utah HB 0411** (2019): This bill enacts the Community Renewable Energy Act in the Public Utilities Code. This law authorizes next steps that will define the rules, rates and expectation for participating communities and customers in Utah desiring net-100% renewable energy.

# DIGITAL DRIVER'S LICENSE

**Utah** one of 6 states joined **apple wallet-** with digital driver's license

Utah's mDL fully utilizes standards outlined by the AAMVA (American Association of Motor Vehicles Administrators)

**Standards are established by ISO (International Organization for Standardization) Guidelines** – A secret committee setting standards for Digital ID's for the world. Based in EU.

“Architects of the emerging mDL systems are largely representatives of **government agencies and big companies.**” Pg. 15 **ACLU: Identity Crisis document**

For mDL, **Utah DLD is working** with GET Group North America and its technology partner **Scytáles** to provide GET Mobile ID, an ISO 18013-5-compliant **application that puts an official driver license or ID Card on a citizen's smartphone.**

**Verification:** The contactless ID document can be verified with a tap or scan and is accepted worldwide using any ISO 18013-5 compliant reader, such as **GET Mobile Verify.**

**Verifier ID Tracking-** Verifiers could record and **compile information regarding the mID presentations and gain a large swath of data about a holder's life.**

# VOATZ APP- TROJAN HORSE

SB49 2021 would have entered Utah into a voting app pilot program.

Utah County has signed on with VOATZ app.

Utah County uses **VOATZ** for **oversea voting- Military etc.**

Did you know VOATZ app touts **biometrics** as a form of keeping your information secure?

**Blockchain** is used for VOATZ app- is that secure?

Do we want voting systems connected via the **internet** or to have **internet access**?

If machines are replaced, as they replaced paper, what comes next? VOATZ app

Utah County was the **first to use the VOATZ** app in a **presidential race...** that was **2020**

Should we be voting via our phones? Is that secure?

Should voting be made more "digital" vs paper and locally controlled?

# UIPA- UTAH INLAND PORT

Did you know this is the **single largest economic development effort in the history of the State?**

Focus on **sustainable** and **smart logistics**, development, and industry partnerships. Where have we heard this language before? Hint- UN Agenda

Established in 2018, the Utah Inland Port Authority (**UIPA**) is a **state corporation**.

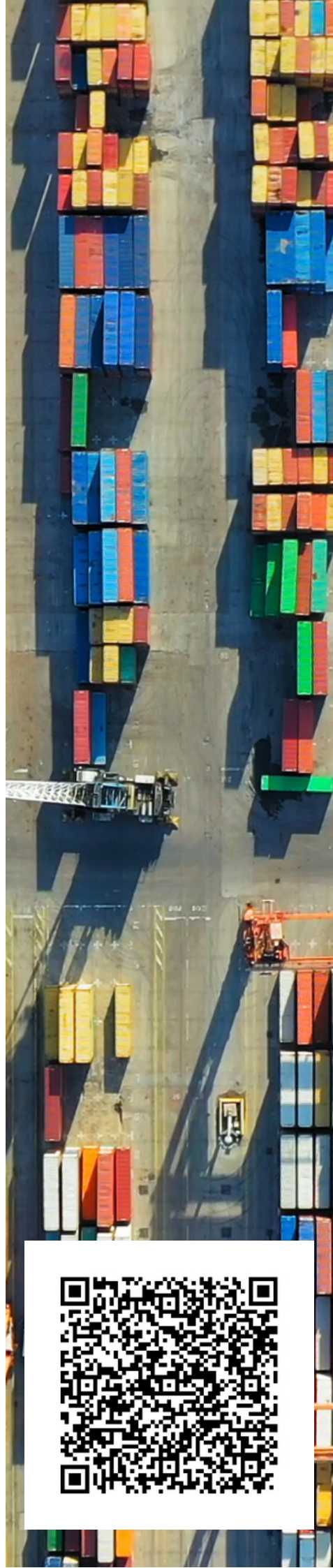
The area would serve as a special trade zone where inbound and outbound goods would be processed, **bypassing coastal ports of entry**.

"**Here at World Trade Center Utah**, we are thrilled to see the inland port moving forward."

HB433 which essentially **prohibits any city from bringing legal action against the port**, or any other challenge to the authority's creation or existence

The Authority sees itself as **the leading trade and logistics hub**? So, their objective is to surpass Long Beach Port and **Hong Kong** as trade hubs?

SB243- State bank loaded with **\$75 million** for UIPA projects
