



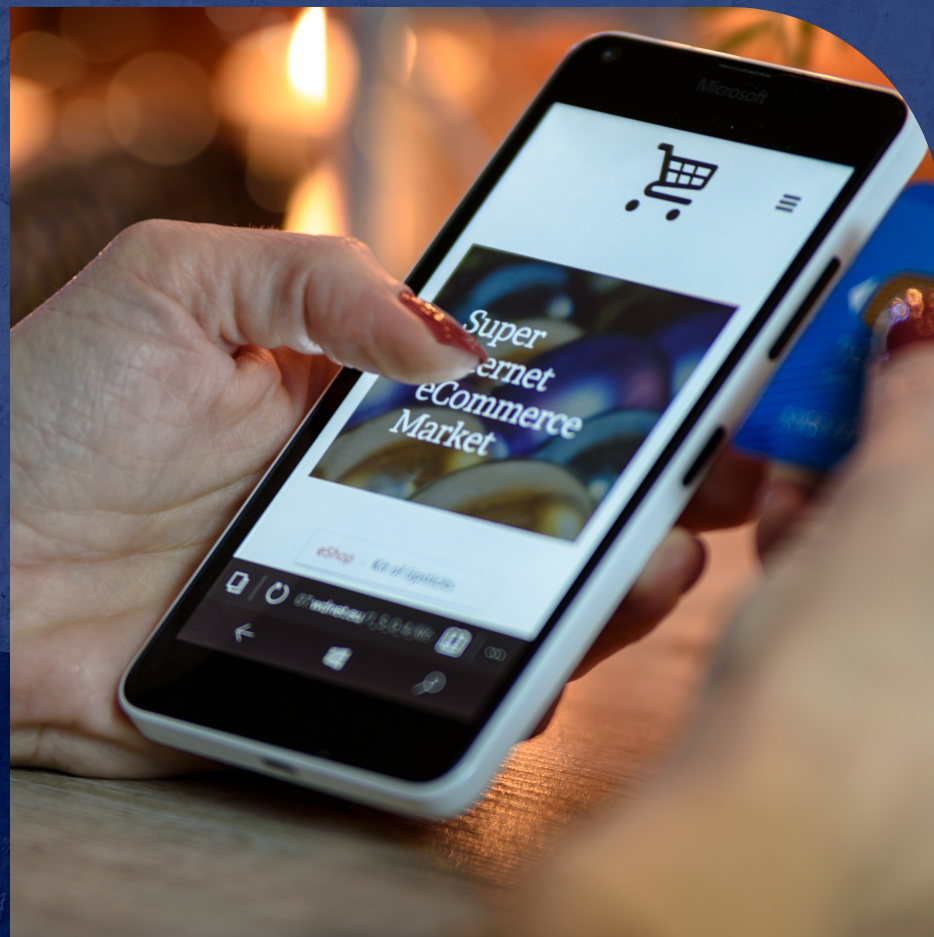

THE HISTORY OF DDL'S IN UTAH

2019

The 2019 Utah Legislature passed SB100 authorizing \$200,000 to begin the process to implement “electronic driver’s licenses”.

July 2021

July 27, 2021- Harmons becomes the first grocer to accept the mDL.

Spring 2021

Utah begins a pilot program of 100 participants, to be expanded to 10,000 by the end of 2021. Widespread production to begin at the start of 2022.

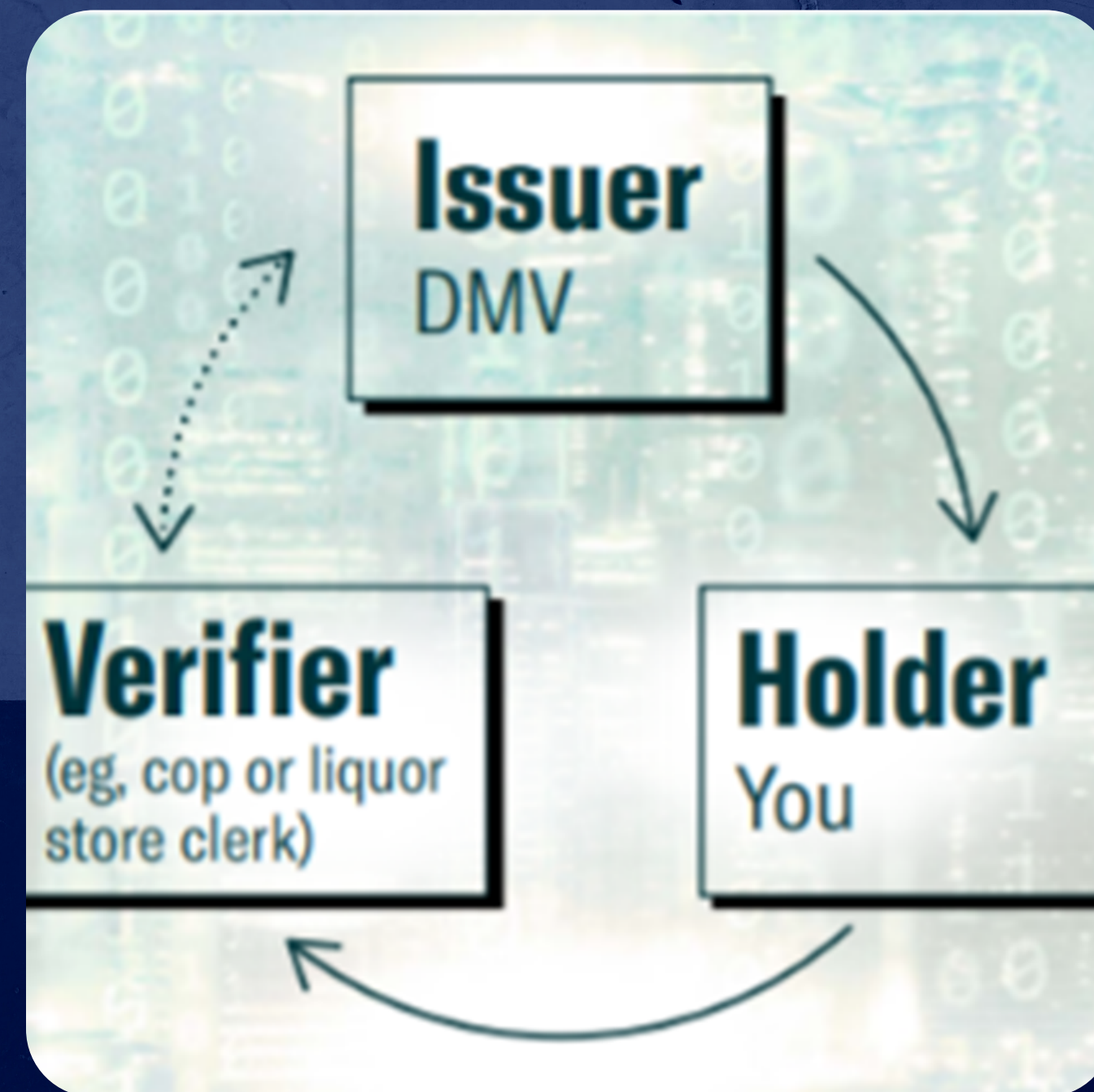
2022

Proposed state-wide implementation of the digital driver’s license program.

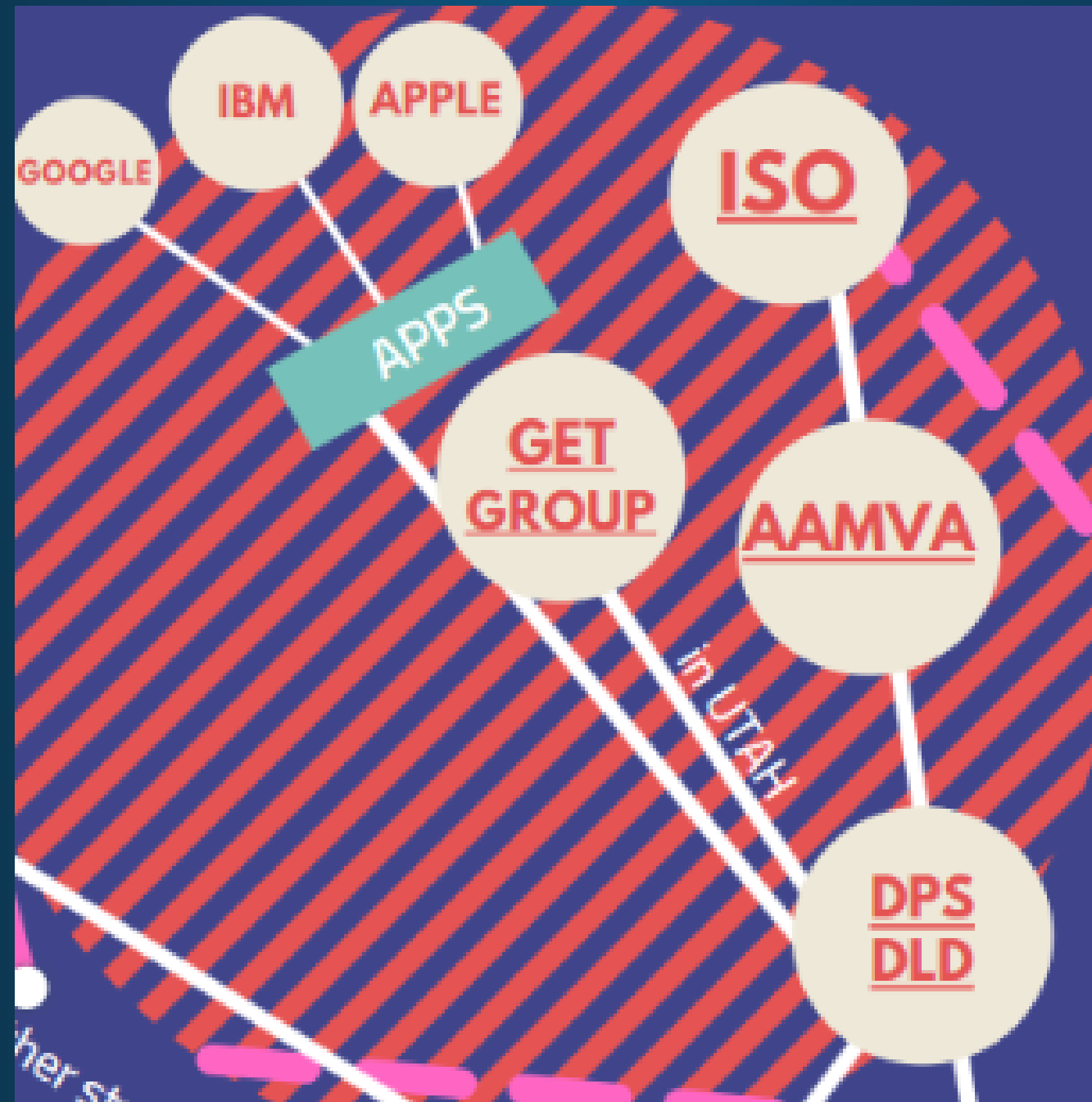


How the Backend to Front end Process Works

The Tech and Standards Behind DDL's



ID4D & ID2020
The aim to bring legal, binding, digital IDs to all world's citizens

UN Sustainable Development Goal 16.9 calls for legal identity for all people worldwide, including birth registration, by 2030

ISO has been actively engaged with the United Nations (UN) since 1947. The long-established history of collaboration between the two organizations has been essential to tackling global challenges and will continue to be a transformative force in the future, as we pursue the implementation of the UN's Sustainable Development Goals.

A non-profit, is a tax-exempt, (non-governmental) organization, developing model programs in motor vehicle administration, law enforcement and highway safety. The association also serves as an information clearinghouse in these areas, and acts as the international spokesman for these interests

The state of Utah is conducting a pilot with our technology, which is the first pilot in the country to fully comply with ISO/IEC 18013-5. **Compliance with the standard will ensure mDLs and mIDs issued in one state will be recognized as legal forms of ID anywhere in the world.** This is essential to the continued growth of a global mDL ecosystem.



4 Myths about DDL's in UTAH:

1. Privacy Myth- SB88 cannot guarantee privacy because Utah's mDL is determined by an international private corporation ISO due to compliance with 18013-5.


2. Convenience Myth- This is a solution in search of a problem. Alabama had digital ID's for 5 years and almost nobody needed it or used it. Convenience is not worth handing over our state ID to federal and international players.

3. Optional Myth- The AAMVA says: "It is anticipated that, for the time being, an mDL will be an option." In addition, once an ID hits the federal level, there can be no control over this aspect, as seen in the case of REAL ID. It was only optional until it wasn't.

4. "Small thing" Myth- This bill is not minor. It is part of a global push to create interconnected digital ID's, and Utah is piloting it. India's attempt at this, for example, created massive suffering for the poor, causing several deaths due to hunger because of not having the digital ID. China is using this to persecute a minority. Nigeria has already made digital ID mandatory.

Utah 2013 SJR 11– Rejects UN Agenda 21

This joint resolution of the Legislature rejects United Nations Agenda 21 and urges state and local governments across the United States to reject it.

12 **Highlighted Provisions:**

13 This resolution:

- 14 . rejects United Nations Agenda 21, both its intent and its potential for abuse;
- 15 . urges Utah's state agencies and political subdivisions to not adopt or implement
- 16 policy recommendations that deliberately or inadvertently infringe or restrict private
- 17 property rights without due process;
- 18 . urges Utah's state agencies and political subdivisions to not adopt or develop
- 19 environmental and developmental policies that, without due process, would infringe
- 20 or restrict the private property rights of property owners;
- 21 . urges state and local governments across the United States to be well informed
- 22 regarding the underlying harmful implications of implementing United Nations
- 23 Agenda 21's strategies for "sustainable development";
- 24 . urges state and local governments across the United States to not enter into any
- 25 agreement, expend any sum of money, contract services, or give financial aid to

26 those nongovernmental and intergovernmental organizations affiliated with Agenda 21;

- 27 . urges state and local governments across the United States to reject United Nations
- 28 Agenda 21 and any grant money or financial aid attached to it; and
- 29 . urges support for locally directed regional planning efforts that protect local
- 30 sovereignty and private property rights.

Apple's Privacy Issues:

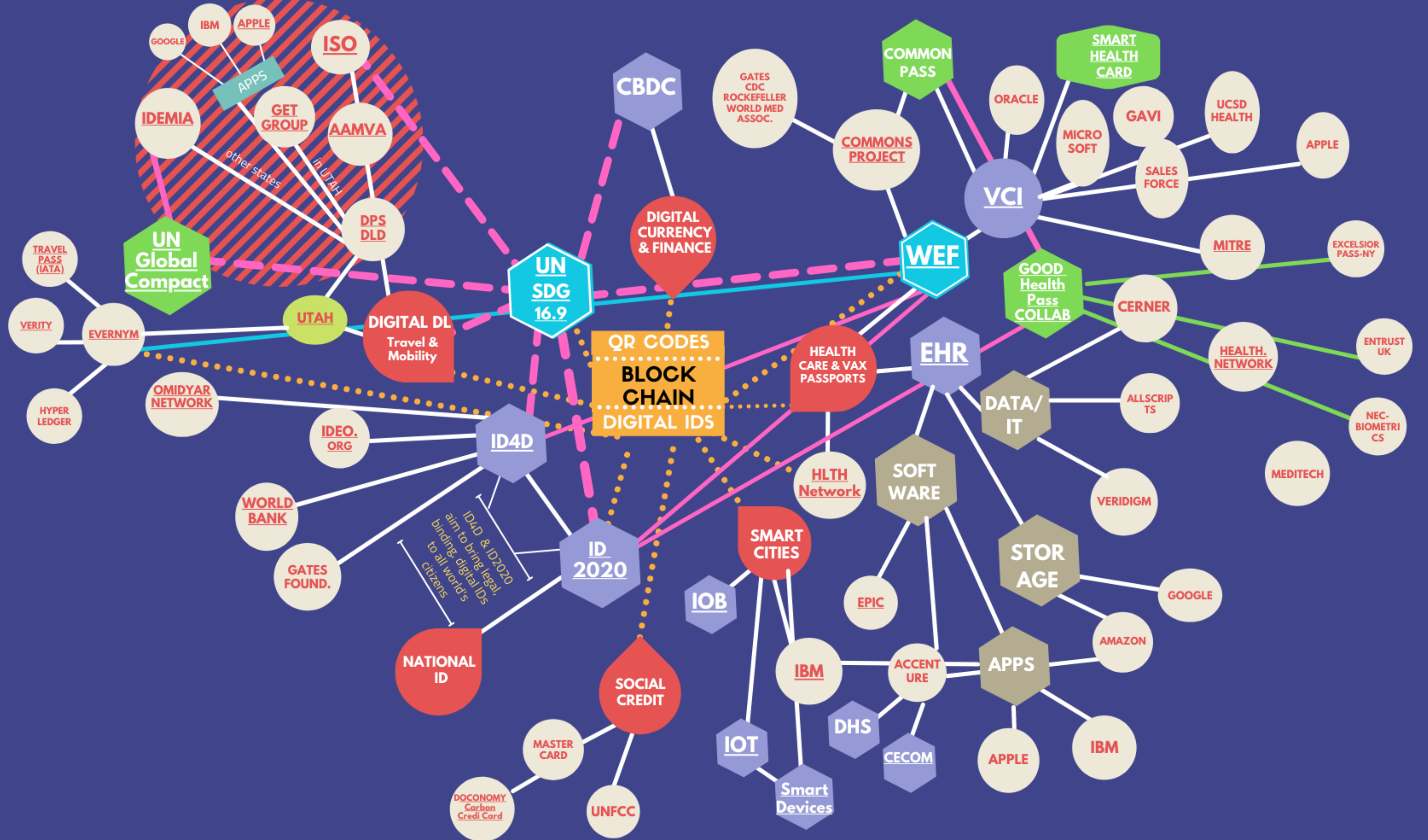
But while both French regulators gave a thumbs-up to that feature, called Apple's App Tracking Transparency, the privacy watchdog gave the iPhone maker's own ad business a more damning assessment.

"Apple's advertising processing requires consent when it involves reading or writing data on the user's device," the Commission nationale de l'informatique et des libertés, or CNIL, wrote in its internal document. "Apple's practices suggest a lack of consent collection."

The nonbinding assessment — which is cautiously worded since it is designed to inform another case, rather than provide grounds for a standalone investigation — throws doubt on Apple's privacy credentials.
